EDGD name change

New Business

PIC III Update – See Submitted PIC III Report

K-12 registration rates have been reduced – in order to increase participation

30% handling fee from ASEE – appears to be appropriate and mostly covers the cost for administrative effort for checks, etc.

ASEE Board of Directors have approved the funding for a new Monolith system

Division can pick a WIP (work in progress) for best paper; however, it will not be considered at the PIC level

Operating accounts are to be eliminated and all funding originally routed there will now be placed in BASS account

Formation of Non-Bylaws Committees

Lulu mentioned in an effort to better prepare newer division leadership and to promote better participation from the newer members of the division to create several non-bylaw committees (award review, membership/communication, EDGJ, and Program Committee).

Bob suggested that they can review the division by-laws, reach out to the executive committee, or older division membership.
